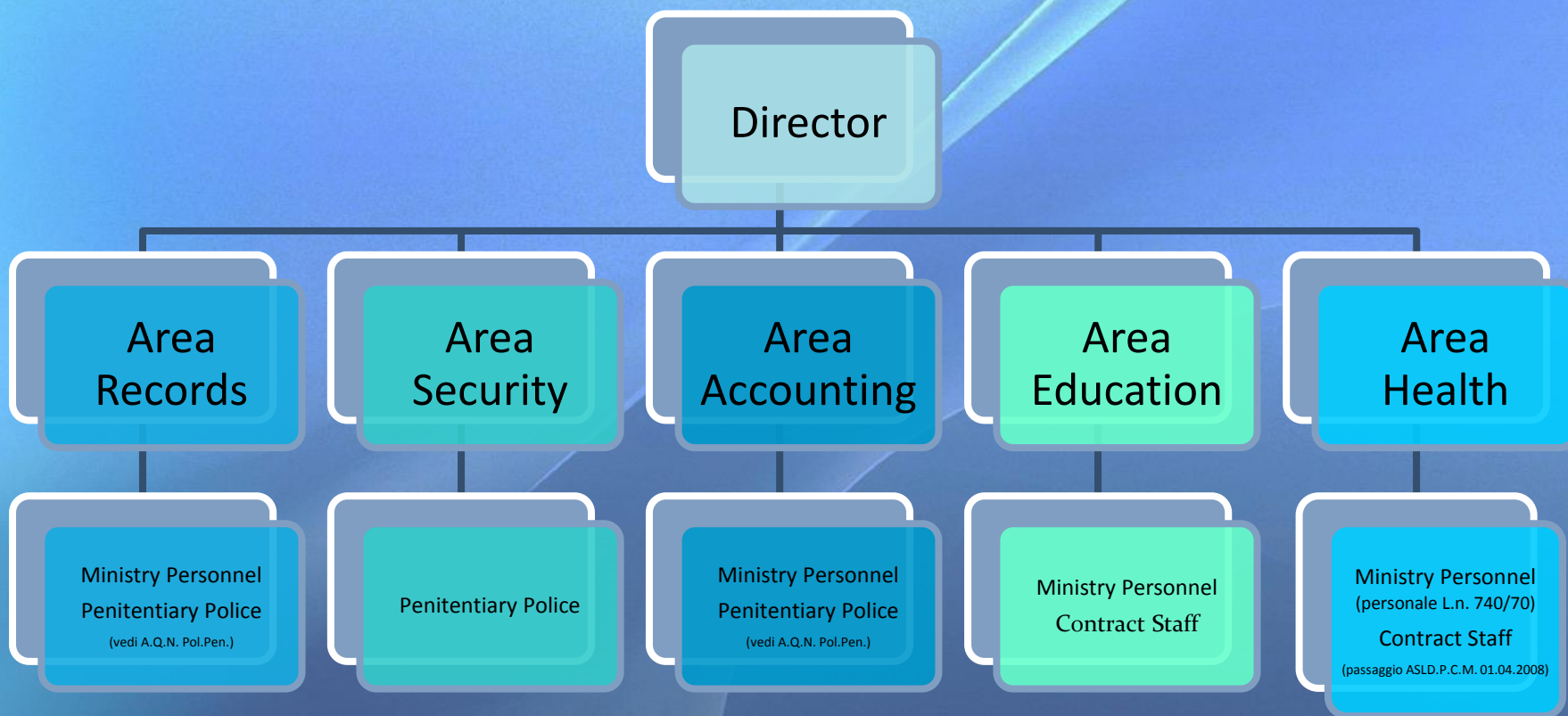

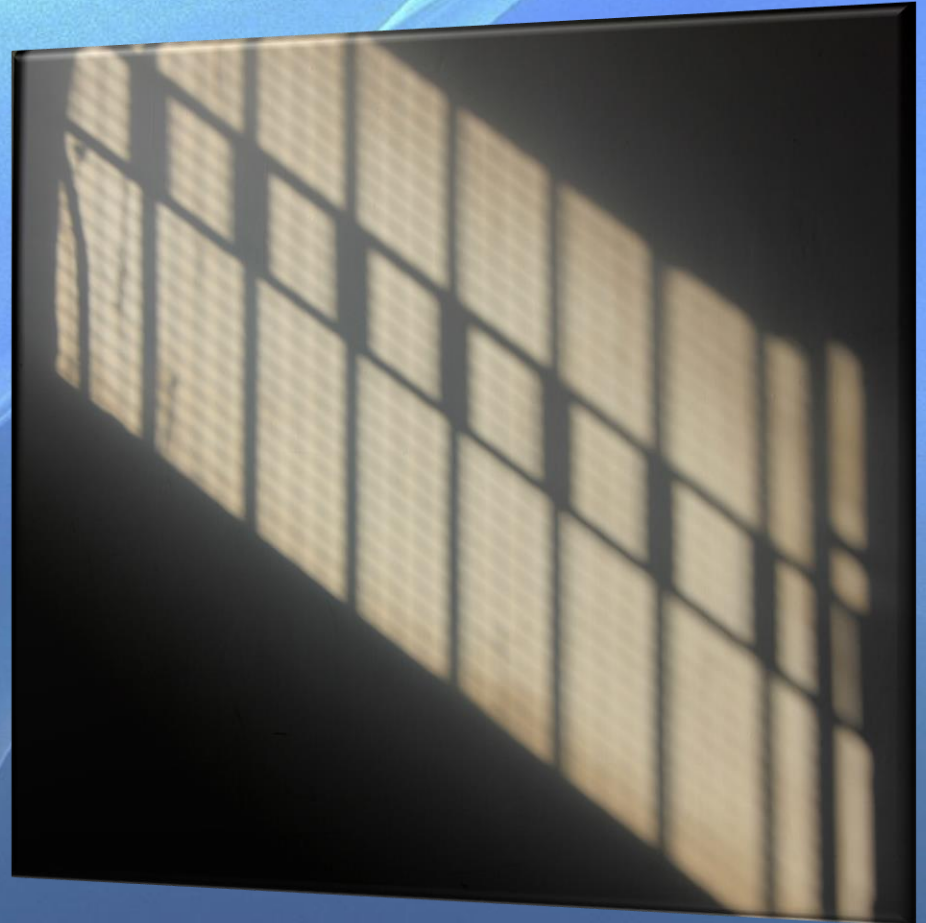

## ***“Circuito” A.S.***

New norms (circolare n. 3619/6069 del 21 aprile 2009)

### ***3 “sub-circuiti”***

#### **A.S. 1**

Inmates belonging to organized crime of mafia type, coming from regime ex. 41bis O.P. as consequence of a complaint accepted by the Surveillance Court

#### **A.S. 2**

Inmates for crimes committed for the purpose of terrorism, or disruption of the democratic order, by committing acts of violence

#### **A.S. 3**

Inmates belonging to organized crime, defendants or convicts under art. 416bis C.P. or those who (under the same article provisions) acted with the purpose to facilitate activity of mafia associations.

## Treatment in A.S. Divisions

Separation of inmates of “Medium Security”  
(Circ. n. 3359/5809 del 21.4.1993)

All legitimate penitentiary activities (walks, education, training, work, religion, recreation, sport) must take place strictly inside the detention area and directly connected ones  
(Circ. n. 3479/5929 del 9.7.1998)

Division A.S. “Does not imply a difference of the penitentiary regime in relation to rights and duties nor in relation to the possibility to apply rules and opportunities of the penitentiary regime”  
(Circ. n. 3619/6069 del 21.4.2009)

## Declassification of A.S. Division

(Lett. Circ. n. 20 del 9.1.2007, Nota n. 75 del 2.2.2007 Direz. Gen. Detenuti)

Evaluation and authorization from the Inmates and Treatment General Direction

Proposal of de-classification presented by the Prison Direction inclusive of:

- G.O.T. opinion
- Judiciary documentation possessed by the office
- Information acquired from the related Police authority
- D.D.A. opinion

# *“ REBIBBIA ”*

## Regime under Art. 41bis (c.2 O.P.)

For **grave reasons of order and public security**,  
also on request by the Ministry of Interior Affairs,  
the Minister of Justice has the faculty **to suspend** in whole or in part



the application of the treatment rules and of the O.P. procedures that might concretely  
contrast with the need of order and security



for inmates, defendants, and those convicted under ex Art. 4 bis 1° c. O.P.



# *“ REBIBBIA ”*

## Suspension of Rules

“Necessary restrictions to satisfy the need for order and security and to prevent contacts with criminal association”  
(Corte Costituzionale)

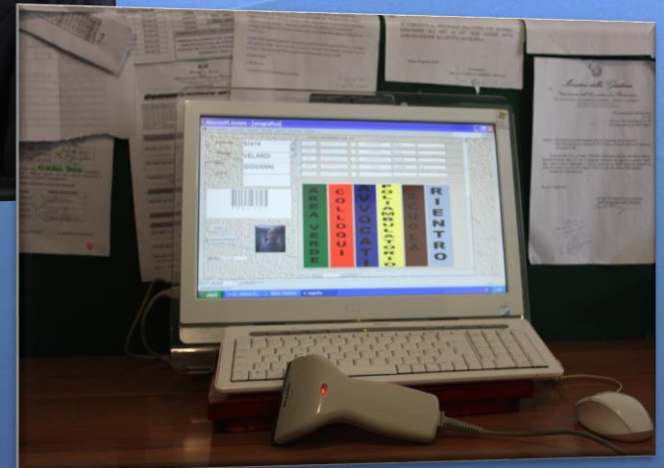
“Applied restrictions of the ordinary penitentiary regime can not be determined freely, they can only be (always within the limit of the forbidden impact on the quality and quantity of the punishment and of treatments congruous to the sense of humanity) those congruous with the goal of order and security” (Sentenza n. 376/1997)

“The regime’s application cannot imply suppression or suspension of the activity of individualized observation and treatment, nor preclusion to the inmate’s participation in cultural, recreational, sport activities, which are necessary to the realization of one’s personality” (Sentenza n. 376/1997)

“Penitentiary administration can suspend the application of rules and institutes which within the penitentiary system belong to the competence of each penitentiary administration and refer to the detention regime in strict sense” (Sentenza n. 349/1993)

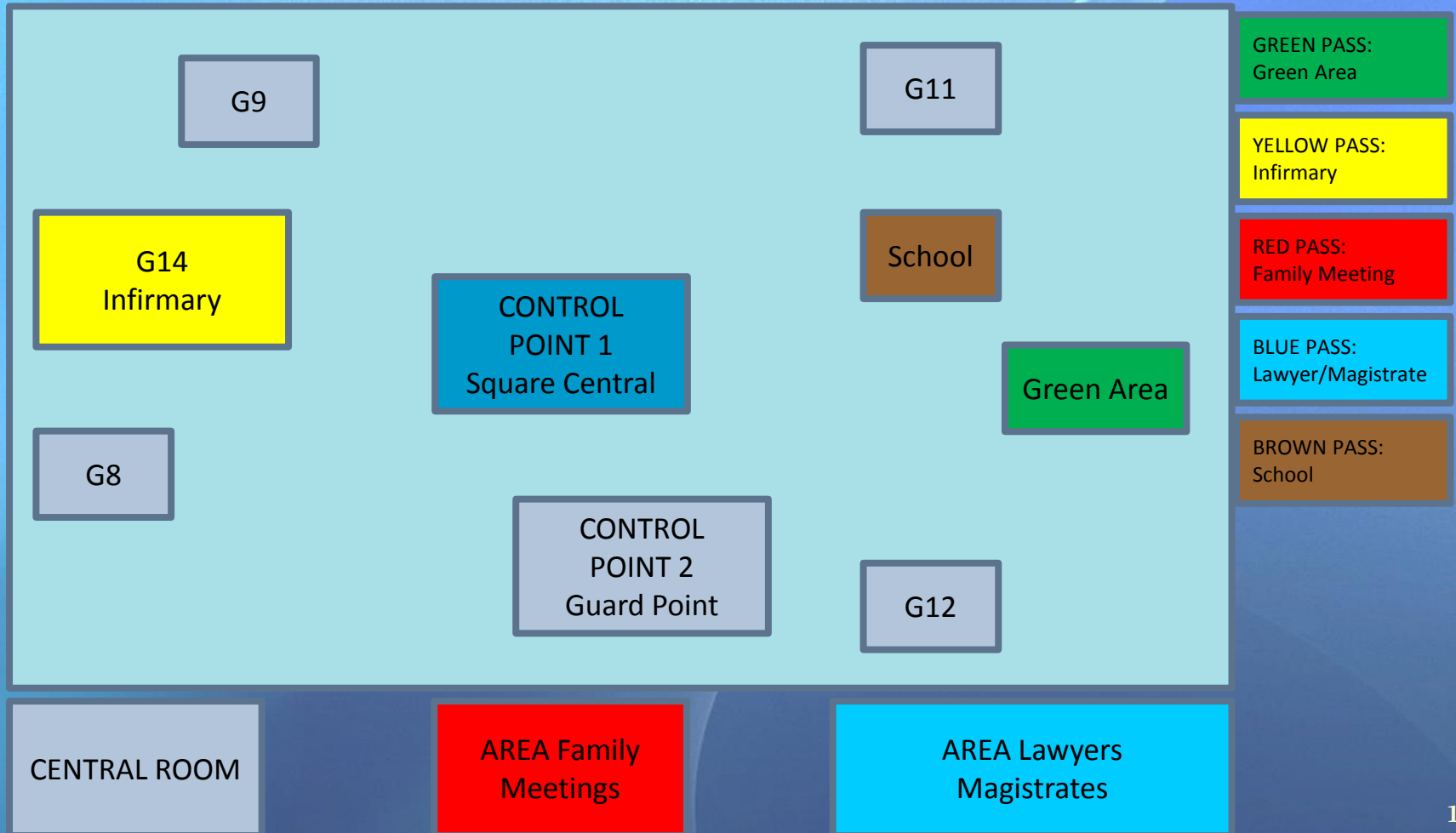

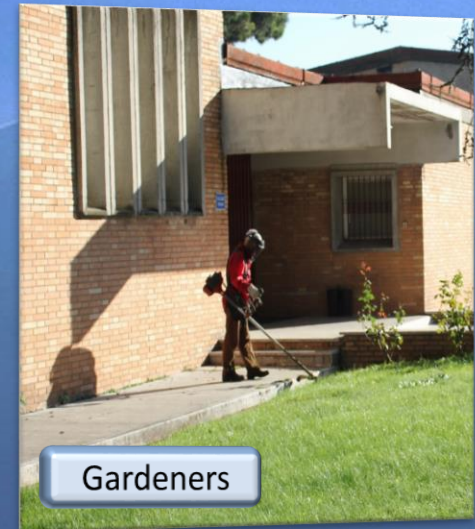
